

Virtual South32 Rottnest Channel Swim Event Organiser Terms & Conditions

In this section, "Rottnest Channel Swim Association" and "South32 Rottnest Channel Swim" means the Rottnest Channel Swim Association Inc.

"Event Organiser", "I", "me" and "my" means the purchaser of a Virtual South32 Rottnest Channel Swim pack and all organisers of Virtual South32 Rottnest Channel Swim events.

"Swimmer" and "Participant" means people who purchase tickets to the event organiser's Virtual South32 Rottnest Channel Swim event.

Event Rules

1. I will uphold and enforce all Virtual South32 Rottnest Channel Swim event rules.
 - 1.1. Any swimmer that disobeys/breaches any of the event rules will be disqualified from my event.
 - 1.2. I will ensure all completed lap recording schedules will be submitted to info@rotnnestchannelswim.com.au at least 1-week post-event.

Copyright

2. I must receive written permission to use the Virtual South32 Rottnest Channel Swim, South32 Rottnest Channel Swim or Rottnest Channel Swim Association logo for marketing or any other purposes.
 - 2.1. The Rottnest Channel Swim Association must see the drafted material before permission can be granted.
 - 2.2. This does not include material provided by the Rottnest Channel Swim Association to the Event Organiser to assist in the promotion of the event.
 - 2.2.1. The material provided by the Rottnest Channel Swim Association can not be significantly changed without approval from the Rottnest Channel Swim Association.

Liability

3. I understand that while hosting a Virtual South32 Rottnest Channel Swim branded event, I am obligated to uphold the quality and standards of the Rottnest Channel Swim Association.
 - 3.1. I will ensure all participants, receive the merchandise provided by the Rottnest Channel Swim Association.
 - 3.2. I will ensure all swimmers are aware that I, not the Rottnest Channel Swim Association, am the organiser of the event.
 - 3.3. I will not place blame on the Rottnest Channel Swim Association for any issues I have with running my event.
 - 3.4. If there are any issues with the running of my event, I will contact the Rottnest Channel Swim Association as soon as possible.
 - 3.5. I understand that, should my event be found to not uphold the quality and standards of the Rottnest Channel Swim Association, I may not be permitted to hold any future events organised by the Rottnest Channel Swim Association.

Personal Information

4. Any personal information provided by swimmers to me will be stored securely.

Support/Safety

5. I will offer support to all participants before, during and post-event where required.
 - 5.1. Once a question/enquiry is received from a participant, I will reply as soon as possible.

- 5.2. I will offer support with registrations, payments, event rules, general enquiries and any other enquiries about my Virtual South32 Rottnest Channel Swim event.
6. I will ensure that the event area meets all OH & S regulations as per my legal obligation.
7. I will ensure a currently trained/qualified first-aider is present and able to act in the case of an emergency during the entirety of my Virtual South32 Rottnest Channel Swim event.
 - 7.1. This person cannot be a swimmer participating in the event.

On-selling items

8. All items as part of the Virtual South32 Rottnest Channel Swim packs are to be used in the running of an event and/or fundraising. None of the items provided can be on-sold.

Excess Stock/Refunds

9. No returns for any unsold or excessive stock will be accepted.
10. No refunds will be provided after the purchase has been processed for change of mind, accidental purchase or inability to acquire event-goers.
 - 10.1. Replacement merchandise can be exchanged for faulty merchandise.

Illegal/Fraudulent Activities

11. If I am found to have been conducting any illegal/fraudulent activities through or during the event, I understand I may be banned from holding any future events organised by the Rottnest Channel Swim Association.
